Now on this 18th day of June 2024, the Board of Commissioners, Sheridan Kansas, County, met in regular session with Chairman Mike "Buck" Mader presiding. Other members present were Joe Bainter, David Stithem, Harry Joe Pratt County Attorney and County Clerk Heather Bracht. Guest was The Sheridan Sentinel.

At 8:00 a.m. Mader called the meeting to order.

Those in attendance stood and recited the Pledge of Allegiance.

Mader made a motion to amend the agenda to include Andrea Cross from Options. Bainter seconded. Carried 3-0. Cross discussed the services provided through Options and answered a few questions.

Joe Herskowitz, Road & Bridge Supervisor, came to the table. Herskowitz advised the Board that a new culvert had been put in on 10E.

There was discussion about the fencing that will be done at the landfill.

There are currently three graders that have some problems.

Review of some of the roads was discussed. The Board

and Herskowitz reviewed the County's policy on steel toed boots. It was tabled and will be further discussed at the next meeting. Herskowitz advised the Board he had received the paperwork from the State for the landfill and the disaster relief funds. He will check with the State and see what end date he should show.

Pratt and the Board discussed vacating a trail road on Dwayne Kersenbrock's property in the SW4 of 23-8-29. Pratt will proceed with talking with Kersenbrock and completing the necessary paperwork.

Bracht had requested from Karl Pratt information on what he had done as Economic Development Director, and that information was distributed to the Board for review.
